Physical and Mobility Disabilities

- › Mobility challenges may be caused by a chronic health condition, a congenital condition, an accident or an injury.
- › People with mobility challenges often have difficulty using their legs or feet or may fatigue easily or have difficulty traveling long distances.
- › In the United States, 10 percent of adults report having a mobility difficulty. This number is expected to grow as the number of people with these conditions is expected to increase dramatically throughout the next decades.
- › In 1990, Congress passed the Americans with Disabilities Act (ADA), mandating that reasonable accommodations are made so that people with disabilities can access public buildings and spaces. Religious organizations are not required to adhere to the ADA.

Ministry Challenges

People with mobility issues may be prevented from participating in the life of the church by the following challenges:

- › **Negative attitudes and thoughtless actions** displayed by people within a congregation can send a strong message to a person with a mobility disability that they are not welcome in the congregation.
- › **Environmental challenges** from a communion rail only reached by stairs or narrow pews, to a round bathroom door handle, to a coffee dispenser placed on a high counter. The setup of the surrounding environment can provide barriers to people with mobility issues.
- › **Financial challenges** from the cost of an elevator, to the cost of expanding a bathroom, to the cost of repair for a wheelchair lift. Owing to limited finances, some congregations with good intentions may find it challenging to include people with mobility challenges.
- › **Spiritual challenges** from the temptation of the world, of the devil, and our flesh. Like all people, a person with a mobility disability needs to know about the love, mercy and forgiveness of Jesus.





Ministry GOAL

Break down barriers and attitudes to welcome, witness and be in ministry with people with mobility disabilities participating in the life of the church together.
